## Budapest Comic Con POLICY

By purchasing the ticket our visitors acknowledge and accept the following points of the Budapest Comic Con POLICY for the whole duration of the event, and issues not regulated by Budapest Comic Con POLICY shall be governed by the regulations of the event venue.

By entering the event, the visitor knows the legal consequences, so declares and acknowledges, that participating at the event at his / her own decision and risk, and declares and acknowledges that the organizer excludes all liability for any accidents or injuries that may occur during the event.

### ENTRY

- Entry to the event is limited to the entry points designated by the organizers.
- Entry and participation in the event is permitted only during the validity period of the purchased ticket.
- Children under the age of 14 (fourteenth) may only enter and participate in the event area with a legal adult.
- A maximum 0.5 liters of pet beverage can be brought into the event area.
- The organizer reserves the right to restrict the objects and equipment that may be brought into the territory of the event in order to ensure the safety of the event.
- It is forbidden to drive into the event area without entry permission. Persons with an entry permission are also required to comply fully with the highway code at the event. It is recommended to use public transport and taxi service to approach the event.
- Taking photos and videos with large cameras are not allowed without prior accreditation. During an event shooting is only allowed 5 minutes after the event starts or 5 minutes before the event ends. Some events / programs may prohibit taking photos and videos. Important! It is forbidden to take photos with guests, except at official photo ops additional engagement programs.
- The event is open to all ages, everyone is welcome.

### **VIP LOUNGE:**

- Entry to the VIP LOUNGE is only with VIP pass wristband.
- With a VIP pass wristband only one person allows to stay in the VIP Lounge.

### **AUTOGRAPHS AND PHOTO OPS PROGRAMS:**

- Normal and VIP passes of the event do not permit entry to autographs and photo ops programs, and these programs are only available with additional tickets purchased separately.

### **RULES OF CONDUCT, PARTICIPATION IN THE EVENT:**

- The visitor must behave in accordance with the general norms due to the T&C and the Budapest Comic Con policy, as well as the host site's policies.
- The visitor shall refrain from any expression, communication or action that may endanger or violate the privacy, life, health or physical integrity of others. The visitor has a special duty to protect natural values in the area of the event and refrain from damaging them.
- The organizer requests the visitors to use garbage collectors for the disposal of garbage.
- Visitors acknowledge that the organizer can record audio, photo and video of the event, so the visitor with the participation at the event allows the recording and communication of his/her face and appearance. Due to the audio, photo and video recordings published regarding the Budapest Comic Con, the visitors may not make any claim to the organizer.
- It is forbidden to conduct any economic, commercial or advertising activity in the event area, including the area in front of the event entrance, without the prior written permission of the organizer.

## FORBIDDEN:

- It is strictly forbidden to bring alcoholic drinks into the event area.
- It is not allowed to bring the event any stabbing-cutting tool or weapon.  
Airsoft weapons can only be brought in without bullets and batteries.  
(Cardboard swords and other non-weapon replicas used for cosplay do not fall into this category.)
- Smoking and fire usage are not allowed in the event area!
- Pets - dog, cat, mouse, rat, reptile, etc. - bringing in is forbidden unless justified by a program or approved cosplayer costume and it is specifically authorized by the organizers.
- Anyone who uses illegal drugs, or at the one we find, that person will be handed over to the authorities!

## SAFETY AND FIRST AID

- Participants of the event may contact the support staff for assistance at the first aid points throughout the event.
- If the visitors of the event recognize an emergency (such as a fire) or an accident case, they must immediately notify any member of the security staff at the event.

- The organizer is not responsible for lost items.
